Business needs

It is also important that, in the case of a data leak, sufficient information is available to establish who was involved, and the context in which it occurred. This record of events should also be tamper proof in case disciplinary action or legal proceedings are required.

Technical challenges

IT departments face the demanding task of implementing a technical solution that will enforce the complex requirements laid down in their organization's email security policy. In addition to stipulating what content can be emailed between whom, the policy may also specify the security level of the email transmission itself, as well as that of the email data when stored.

This poses the challenge of translating an organization-wide policy across a disparate set of systems that could include email encryption, content filtering and email storage solutions. By its nature, this complexity will be prone to inconsistencies in policy enforcement and present difficulties in evidence gathering should there be a policy violation. Also, the ability to rapidly respond to changing policy requirements could be severely hampered.
